



The trucks of this series are characterised by minimum dimensions and a high stability. This pre-determinates them, among other things, also for handling in containers, wagons or in limited storage spaces. Accurate, easy and sensitive controllability is ensured by a hydrodynamic gear with integrated inching. The trucks may be driven by Diesel engines or LPG-combusting engines (these trucks have a "G" type identification). In both cases the trucks can also be equipped with a catalytic converter, enabling their operation in production and storage halls or other closed spaces. The new concept of design was subject particularly to ergonomic needs of the operators while reaching a high aesthetic standard. The new gears, contemporary Lombardini engines and hydrodynamic devices have ensured a minimum noise level of the truck and on the other hand reaching of a high transportation performance. The trucks meet the requirements of EEC Directive 89/392 and of Act No. 22/1997 and they bear the compliance identification of CE and CCZ





The **D** (**G**) 12 - 20 series trucks are intended particularly for work in storage spaces, containers and wagons, to which the low height of the protective frame and the lifting device with a big free lift are adapted. All the trucks of this series are approved for operation on roads and at the Client's wish they can be provided with the obligatory outfit.
